This course aims to familiarize students with contemporary political institutions, processes, and problems in Latin America. The first two weeks provide a general introduction to issues and actors in the region. During the remaining weeks we will examine specific country case-studies. The course materials and lectures emphasize the challenges of democratization, post-authoritarian regimes, revolutionary struggles and social movements, social and economic equalities, and political change in the region. This semester the countries of emphasis will be Mexico, Colombia, Brazil, Chile, Argentina and Cuba.
