This course introduces students to the broad spectrum of social movement studies. Guiding questions include: What are social movements? Why are they created? What do they do? How do they do what they do? And what impact do they have? We will focus particularly on social movement studies that emphasize political opportunity as well as cultural approaches. Using weekly oral presentations, we will analyze case studies from Asia, Latin America, Europe and the Untied States, frequently drawing comparisons between regions and cases. This is a writing-in-the-discipline seminar that requires extensive reading and writing exercises.
