Guidelines for Prelims in the Urban Politics Subfield

Readings and Preparation

Students taking the prelim exams must be familiar with a much greater body of literature than that assigned in coursework. Preparation for the prelim exams requires extensive and intensive readings; there is a lot to cover and the reading must be done with care. To structure the study time and to ensure plenty of guidance and advice, students should plan to take one or more Independent Readings courses prior to the exam, though this is not required (note, however, that the credit earned will be above the minimum number of course credits required for the Ph.D. degree). Additional readings will normally be needed to prepare for the dissertation portion of the prelim exams. Students should consider taking a readings course for this purpose as well.

This bibliography emphasizes general works rather than specialized articles. The list of works is by no means a comprehensive bibliography of all major works in the field. We have identified with an asterisk* the works that are required for all students regardless of specialty or interest. The grader will identify the works that are the most important for the individual student; in addition to deleting some works, the grader may elect to add some readings to the list, depending upon the preparation and the intended specialties of the student. Corrections and/or suggestions for revising this list are invited. There may be changes in the exam procedures or reading list if circumstances demand it.

Exam format

The exam format will vary somewhat, but normally, students are given the opportunity to choose two of three or more questions. The exam is "open book;" students may consult any source while taking the exam, but of course the answer must be original and the sources of major ideas, facts, and data should be cited.

Grading

Exams are normally graded by one faculty member, though other faculty members may be consulted. The grader will be announced well in advance of the exam.
